

Being a Chore Service Worker is not just important work within the community that we love, it's a job that leaves you with a sense of satisfaction that you will always remember.

I started as a Chore Service Worker when my youngest child went to kindergarten. In the summer, I was a gardener (and Mom), but now I had time in the winters to look for work. A friend told me about Chore Service so I filled out an application. The work was perfect for me because I could schedule it during my children's school hours and easily change my schedule if needed. My clients usually lived 5 or 10 minutes from my house so the commute was great. The best part was the time at the beginning or the end of the work when I would sit down and have conversations with my clients. To this day, those relationships remain as fond memories for me.

I was recently talking to a young man who has worked for Chore Service for the past three summers doing outdoor work for clients. The flexibility of being a Chore Worker is just one attractive aspect of the position. Being able to create and maintain his own work schedule allowed for time to pursue his many interests and activities outside of working with clients. He also said the same thing I always used to say when I worked for Chore Service. He enjoyed getting to know the clients and creating friendships with them. Every spring, clients eagerly anticipate the return of this worker and call the Chore Service office to add their names to the list of clients needing outdoor work. Clients have been so thankful to have a dedicated and caring worker and it means a lot to him that they really appreciate his work.

EXECUTIVE Director's report

As I was preparing to put together my first annual newsletter as the new executive director, I decided to look back at the decades of newsletters that were written before me. I now realize just how resilient Chore Service has been over the past 29 years and this past year has been no different.

Since January, I have been entrusted with the position of executive director after being the coordinator and program director for a total of six years. While I haven't changed desks, I have changed the many hats that I wear in my new role. My previous experience of working directly with clients and staff proves invaluable each and every day as I am reminded of how important our mission is to the community. Not only are we providing essential services to our clients, but we are also employing local and caring people within our community to provide these needed services.

Demand for the services we provide is greater than ever. Like many employers across the country, we are also experiencing a shortage of staff despite extensive measures to hire. At the beginning of the pandemic, local organizations collaborated on safety measures and now these discussions include hiring strategies. Our staff remain committed to serving our clients, but the need for services still overburdens our hardworking staff.

Last November, we hired our new Program Director, Patti Palermo. I was fortunate to have a few months transitioning with Patti before assuming my new role. Patti and I are in the office most days and continue to work closely together. With just two full-time office staff, we occasionally have to borrow or share the same hat!

Safety is still a primary focus for both staff and clients. Staff continue to practice COVID safety precautions when seeing clients. In addition to wearing masks, staff are asked to complete screening tools for both themselves and clients to ensure safety for all. While this involves extra steps, both staff and clients have been supportive and understanding of the importance of such precautions.

Last but not least, my favorite new hat that I have the privilege of wearing is getting to know our wonderful donors. I have had the pleasure of meeting several of you already and my hope is that I will have the opportunity to meet everyone in person next year at our Garden Party where we can all be together strolling through one of our beautiful gardens in the Northwest Corner.

As I look at the decades of scattered newsletters on my desk, I notice a common theme from the very first newsletter to the last. Our donors, Board of Directors and staff remain committed to our mission – even during these challenging times. Thank you for your continued support!





CLIENT FUND NEEDS SUPPORT

In April of 2010, Chore started a special Client Fund with a donation of \$3,000 for the purpose of paying for "special" expenses that clients might have. This fund is to pay for things such as snow removal, mowing of lawns, minor home repairs and household items that are not covered by any other resources.

With the extremely wet summer this year, mowing of lawns was quite expensive. We never know what winter will bring, but the Farmer's Almanac predicts a cold, stormy winter. Snow and ice are certain, so there will be a need to help some clients who cannot afford to keep their driveways and walkways safe.

Chore would like to thank the Rhoades-Robinson Trust Fund for its \$10,000 grant. Chore is very grateful for this amazingly generous and continuous support. The mission of the Trust is to help non-profits assist residents of the Town of Sharon. This past fiscal year, three residents who work for Chore part-time provided 23 Sharon seniors with 539 hours of service.

How does Chore Service Work?

Chore Service helps elderly and disabled residents of Canaan, Cornwall, Falls Village, Kent, Norfolk, Salisbury/Lakeville and Sharon with household chores, home maintenance, errands and, occasionally, transportation. The purpose of the program is to help people stay at home safely and independently. Chore Service also provides jobs for local workers. Client contributions are supplemented by a federal grant as well as donations from towns, churches, charitable funds and individuals so that the program can remain affordable for our target population of fixed low-income families. We do not send bills and only ask the financial information required by our grant funding. Clients are provided with a suggested contribution scale and are asked to contribute what they can (if they can) back toward the service. Workers are paid the same rate regardless of the client's contribution.


